- 1. Evidence of Registration with Corporate Affairs Commission (CAC)
- 2. Evidence of Current Registration with Ondo State Bureau of Public Procurement as suppliers or SMEs. While regular contractors must have registered with ODBPP for the

- year 2021. SMEs should submit their Certificate of Participation at the SME Training Workshop organized by the ODBPP in September 2020.
- 3. All SMEs bidding are to follow the Guidelines on the ODBPP Website, which is available at: https://bpp.on.gov.ng/ondo-state-procurement-guide-for-smes-and-bidders-2/
- 4. All regular suppliers are to follow the ensure the submission of the following:
 - i. Evidence of registration with Corporate Affairs Corporate
 - ii. Current FIRS Company Tax Clearance Certificate (2018, 2019 & 2020) having expiry date of 31st December, 2021 in the case of Limited Liability Company.
 - iii. Copy of Personal Income Tax Clearance Certificates (of two Directors for 2018, 2019 & 2020) in case of Limited Liability Companies or the proprietor(s)/partners in case of Ventures or Enterprises) covering (2018, 2019 & 2020).
 - iv. Evidence of company and personal payment of 3 years' Development Levy (2019, 2020 & 2021)
 - v. Evidence of Registration of Business Premises with Ondo State Agency for Commerce, Industry and Cooperatives
- 5. Evidence of Financial Capability and Banking support where required
- 6. Experience/Technical Qualification of key Personnel with evidence of professional registration with appropriate professional bodies where necessary
- 7. Evidence of similar projects executed or ongoing.
- 8. Letter of assent to allow for verification of all documents submitted to ODBPP.
- 9. Original Receipt of payment of non-refundable tender fee of N1,000.00.
- 10. Bidders may bid for one or more lots but bids will be evaluated on lot by lot basis.
- 11. Interested bidders can obtain tender documents and additional information from the Ondo State Bureau of Public Procurement, Governor's Office, Akure.
